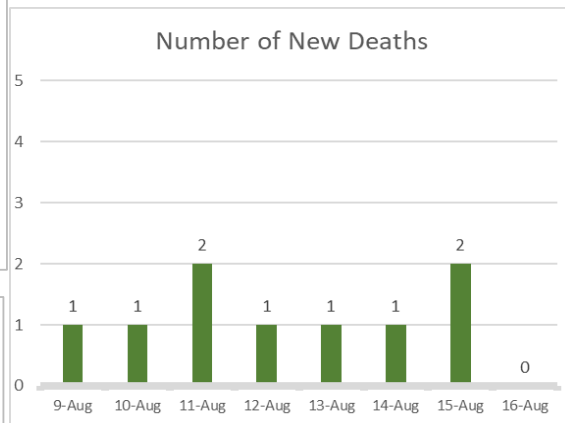
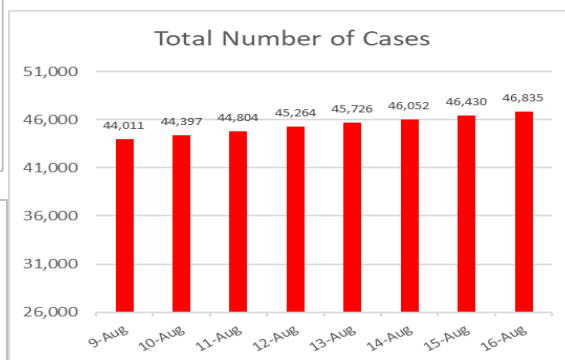
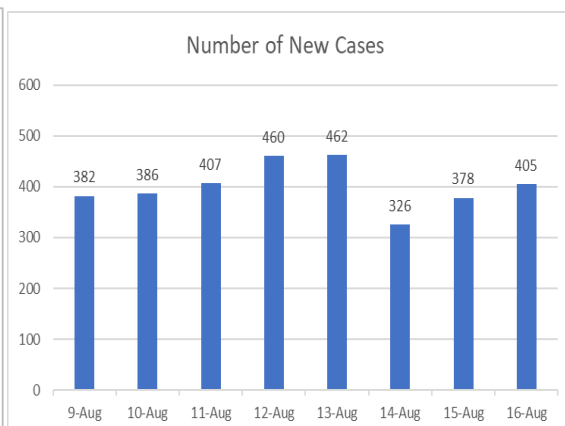

HIGHLIGHTS

- A total of 21,646 violations of not wearing face masks in public places have been recorded since the enforcement period commenced.
- Bahrain Airport Company (BAC) completed auditing the key safety management system measures.
- Legislators have urged a revisit the new proposed public health guideline to further ensure Ashoora is observed safely this year amidst the Covid-19 pandemic.
- The Jaffari Endowments Directorate held remotely its annual meeting of Community Centres and Husseinyia Processions and addressed safe preparations for the Ashoora season.
- A new comprehensive electronic system will be launched next year to track medicines throughout lifecycle: from the factory of origin to the final recipient patient.
- Bahraini Red Crescent Society developed its Response Strategy to COVID-19.
- The President of the Bahrain Medical Association stressed on supporting doctors working on the frontlines of COVID-19 Response.
- The Head of the ICU at Salmaniya Medical Complex affirmed the resolve of Bahrain communities in combating the Corona virus outbreak by enhancing compliance with public health measures to reduce transmission.
