HIGHLIGHTS

- The mortality were: 6 Bahraini citizens (4 male (50, 69,70 and 81 years old) and 2 female (63 and 81 years old)) and 3 expatriates (1 male (56 years old) and 2 female (32 and 79 years old)).
- Increasing number of citizens and residents continue to take COVID-19 vaccine in Bahrain; and Ministry of Health (MOH) revealed that total number of individuals vaccinated as of 2 March 2021 is 302,671.
- WHO revealed that global COVID-19 infections is up for first time in seven weeks.
- Bahrain announced its ambitious plan of vaccinating an additional 300,000 by the end of this month.
- Bahrain now gives the choice to select your second preference of COVID-19 vaccine through the 'BeAware Bahrain' app.
- Mosques in Bahrain will reopen on Thursday, 4 March 2021 for Dawn and Afternoon prayers while ensuring all precautionary measures are implemented.
- Public urged to strictly adhere to health guidelines while taking part in sport to curb the spread of COVID-19.
- Gyms, indoor dining and other pools will only remain closed until March 14, 2021.

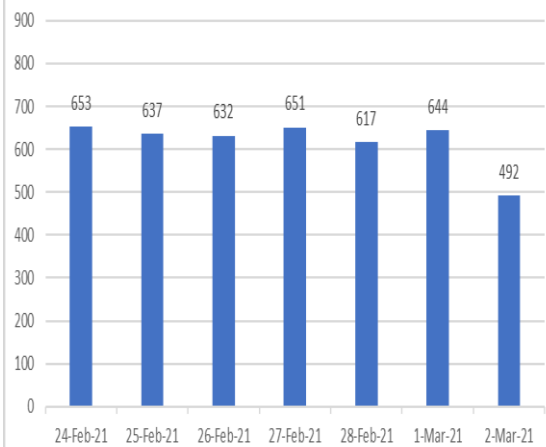

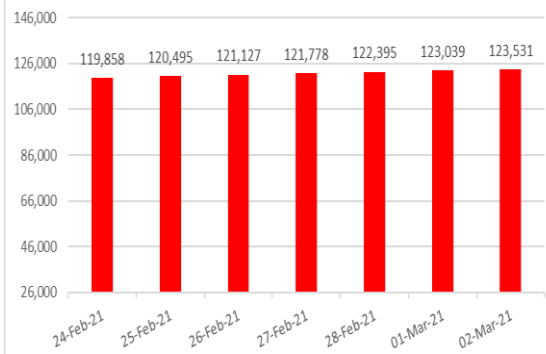
