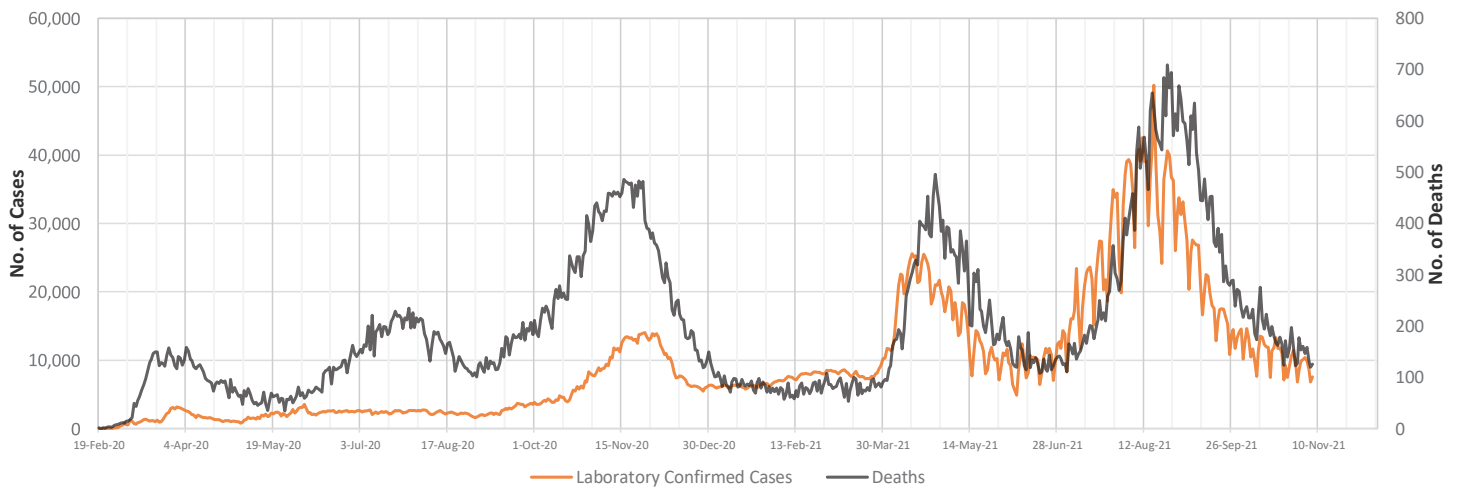

Figure 2 - COVID-19 Patients in Intensive Care, 26 March 2020 - 07 November 2021

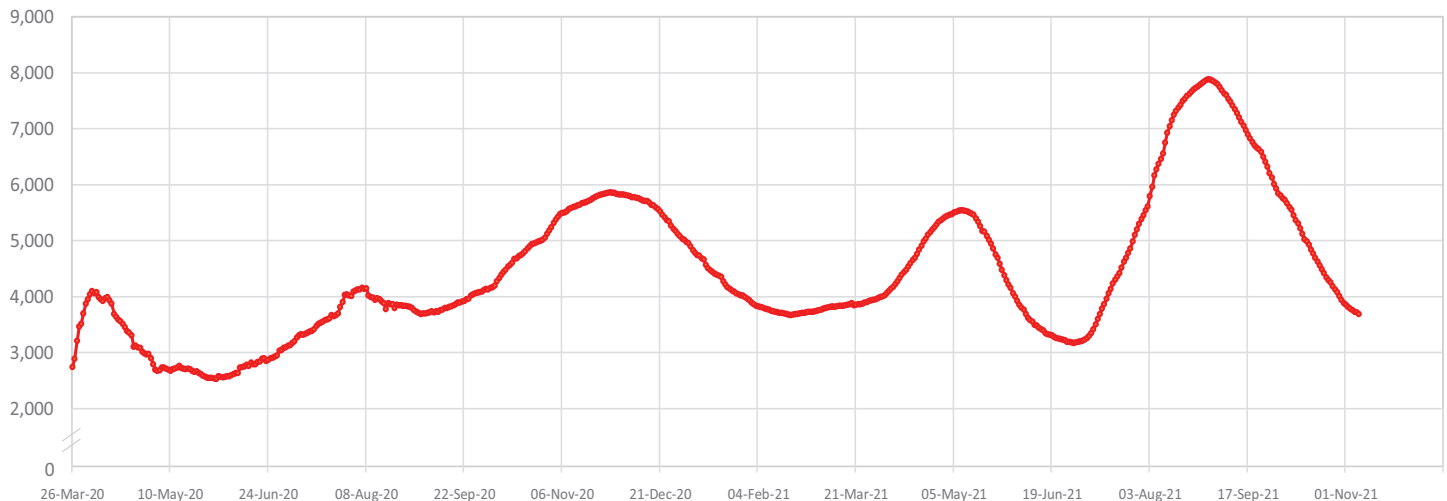
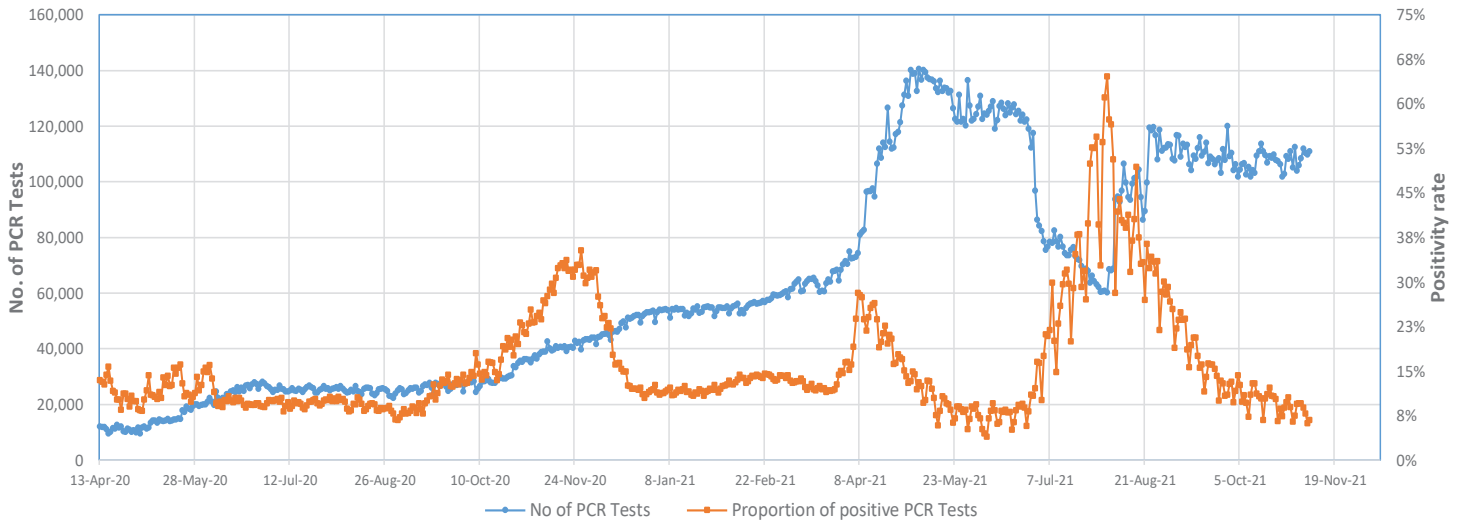


Figure 3 - Number of Daily COVID-19 PCR Tests and Percentage of Positive Cases, 13 April 2020 - 07 November 2021

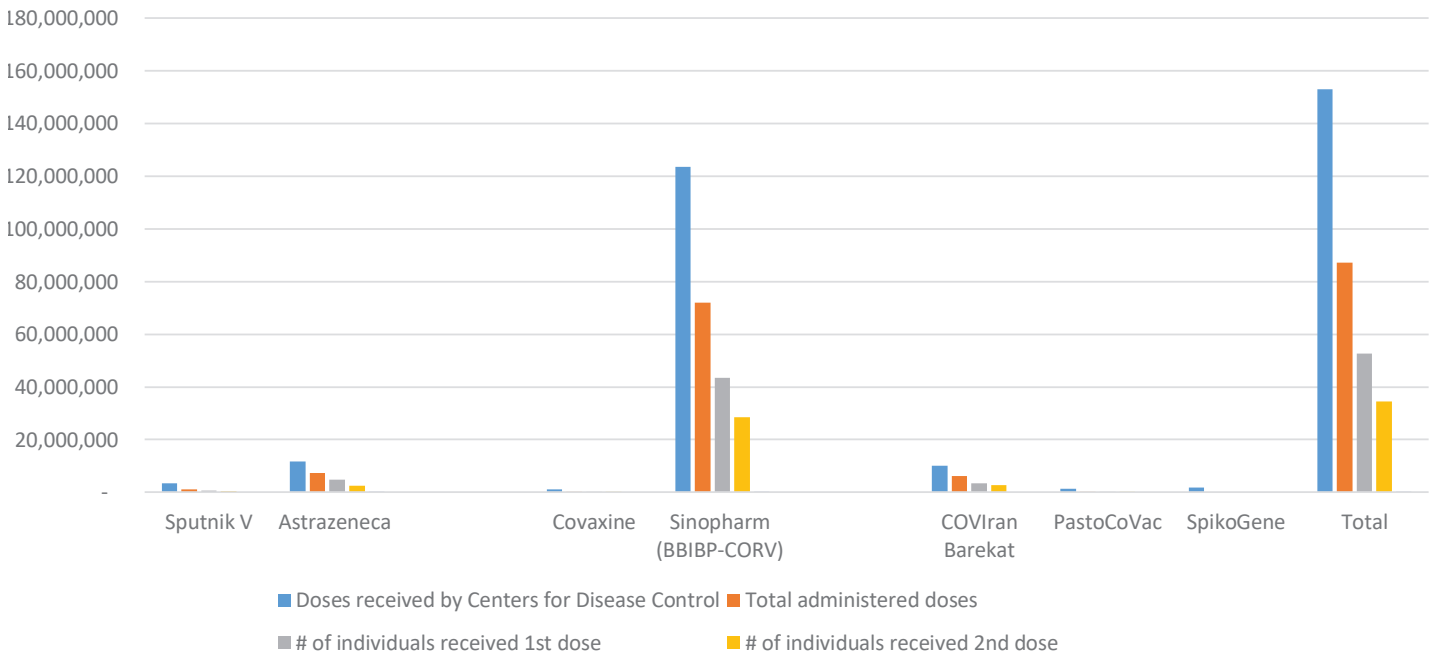

Figure 4- Vaccination Weekly Update (31 October 2021)



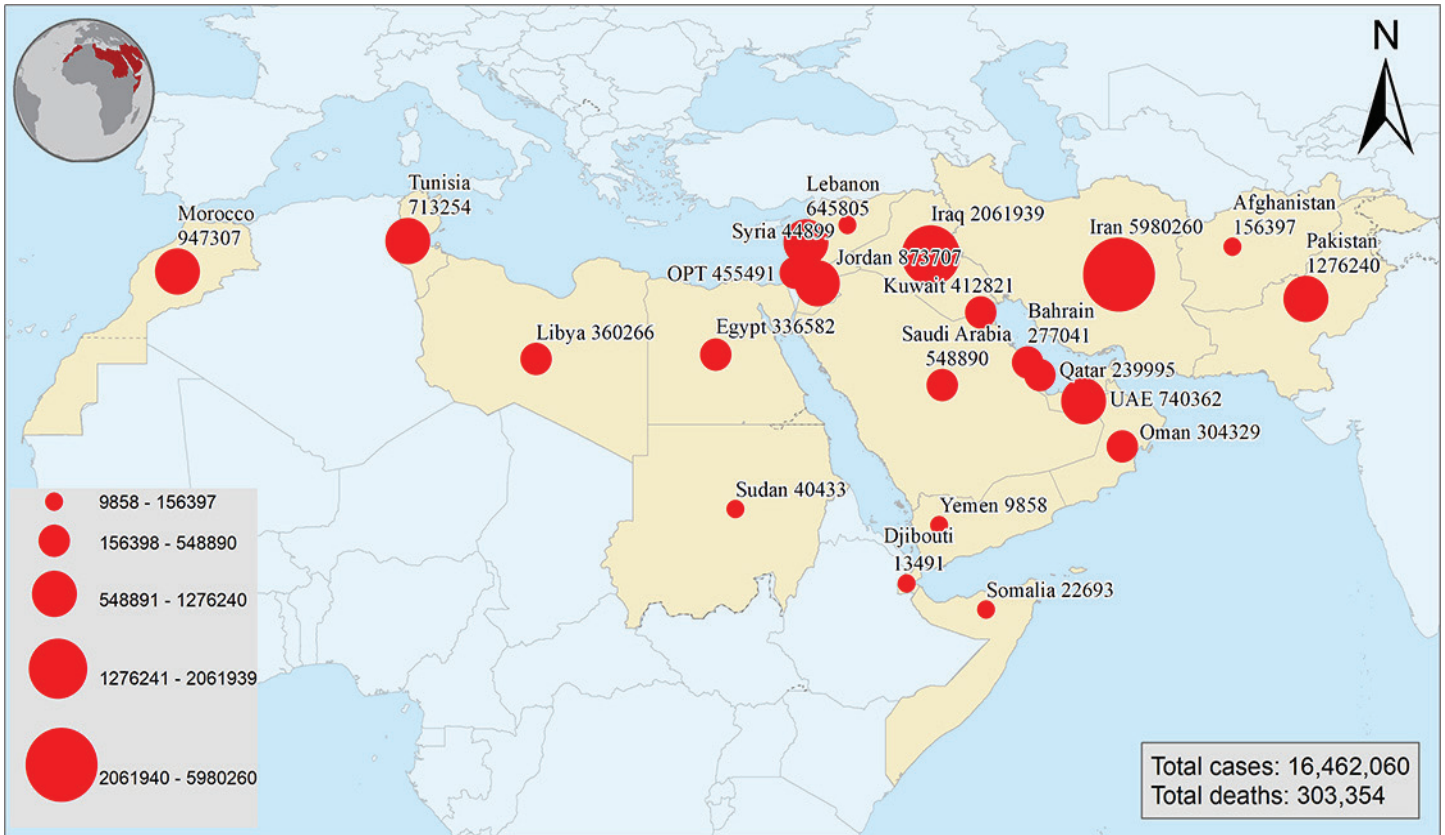

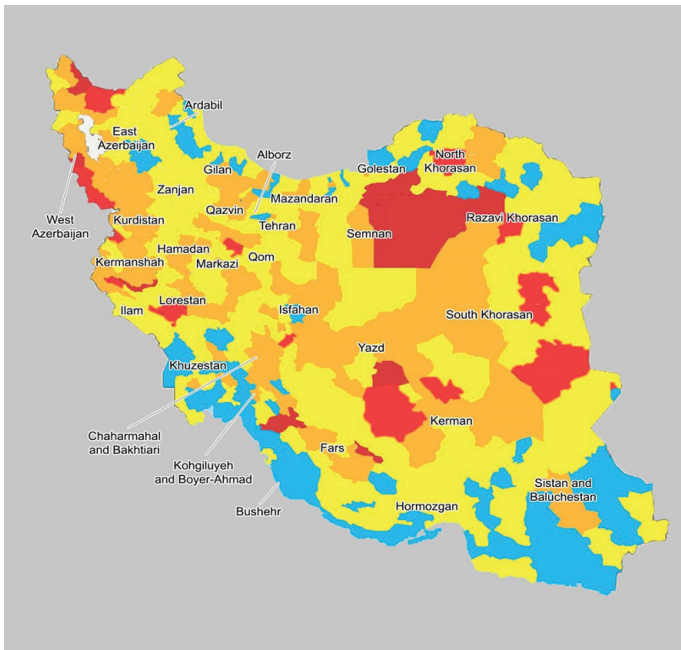

If the number of admitted COVID-19 patients in a city is <2 per 100,000 populations per day, the status of that city will be **blue**; if the number is ≥2 and <4 per 100,000 populations, the status will be **yellow**; if the number is ≥4 and <6, the status will be **orange**; an if the number increases to ≥6, the status will be **red**.

Imposed National and Provincial Restrictions

As a patient-tracking measure, all citizens are required to be in possession of their national ID cards as a prerequisite to gain entry to government offices, receive public services, or use public transport.

As of 21 November 2020, the following scheme, called “smart management of restrictions,” has been implemented nationwide. In this scheme, the alert level for the cities is reviewed weekly, and corresponding closures/openings are applied for one week. More details on the alert level of cities

can be found on the risk map and provincial capitals risk status table.

Technical Deputy of Ministry of Health Environmental and Occupational Health Center announced that reception halls are allowed to operate in cities of blue and yellow status. The maximum number of participants allowable in a hall is 75 people in blue cities and 55 in yellow ones. However, in outdoor halls the maximum capacity may be twice these numbers. The maximum duration of events is 3 hours.

Travel Restrictions Imposed by Iran

(Updated on 07 November 2021)

Highlights:

Currently the restrictions/requirements for incoming passengers based on countries are as follows:

General restrictions:

Except the excluded passengers, all arriving passengers – Iranians and non-Iranians – above 8 years old including diplomats must have negative PCR test result issued at most 96 hours prior to their travel to Iran regardless of duration of stay overseas. The test result must be in English or stamped and confirmed by Iranian consulates. Passengers without negative test result are not allowed to enter Iran.

Passengers with a medical certificate issued longer than 96 hours before travel are subject to medical screening, Coronavirus (COVID-19) PCR test and quarantine upon arrival, at their own expense.

Suspension of visa on arrival facilities for passengers traveling as tourists.

All arriving passengers would be subject to medical screening and clinical assessment and in case of showing symptoms would be tested again. The passenger will be quarantined in assigned locations until receiving the test result and in case of positive

test result, the passenger will be accommodated in assigned quarantine locations for 14 days. Passenger shall incur costs for the test and accommodation. (IKIA Information Center)

All arriving passengers are required to fill out “COVID-19 Self Declaration Form” provided by the airline operators prior or during the flights and hand over the completed forms to the Airlines’ agents. The form can be obtained at <https://www.cao.ir/web/aeronautical-operations-monitoring/maunual>.

Wearing masks at all passenger terminals of Iran airports is mandatory.

Passengers are strongly advised to cross check with their air operators on the latest prerequisites and required documentations regarding negative COVID-19 test result or health certificate.
