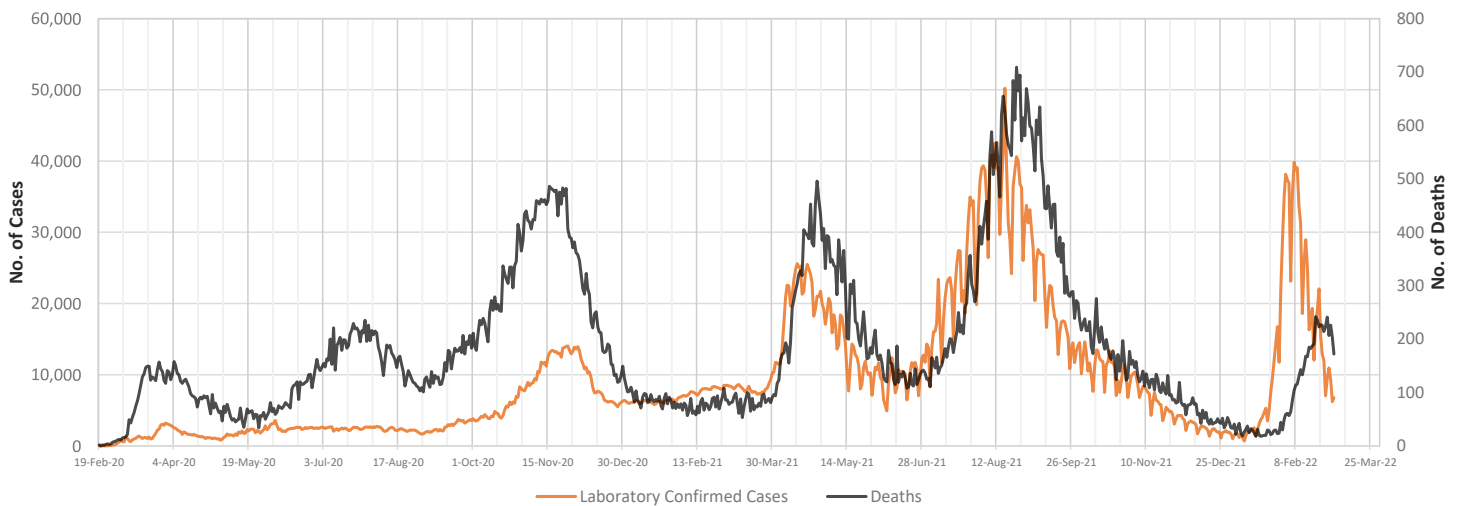

Figure 2 - COVID-19 Patients in Intensive Care, 26 March 2020 - 03 March 2022

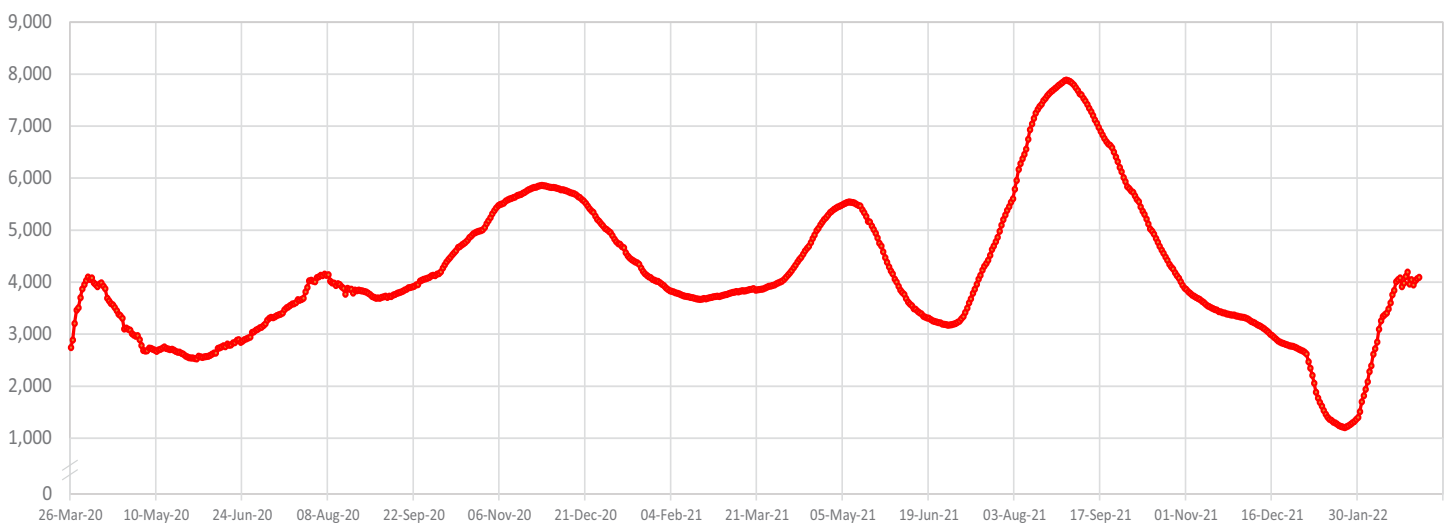
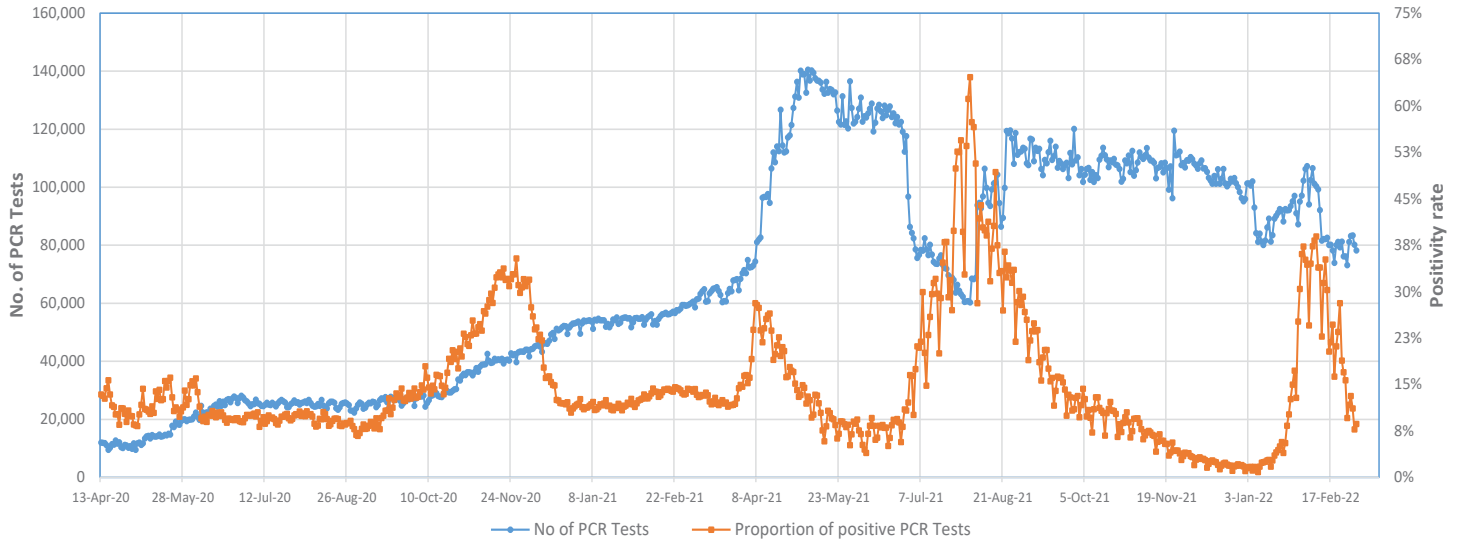


Figure 3 - Number of Daily COVID-19 PCR Tests and Percentage of Positive Cases, 13 April 2020 - 03 March 2022

If the number of admitted COVID-19 patients in a city is <2 per 100,000 populations per day, the status of that city will be **blue**; if the number is ≥2 and <4 per 100,000 populations, the status will be **yellow**; if the number is ≥4 and <6, the status will be **orange**; and if the number increases to ≥6, the status will be **red**.


Imposed National and Provincial Restrictions

As a patient-tracking measure, all citizens are required to be in possession of their national ID cards as a prerequisite to gain entry to government offices, receive public services, or use public transport. Technical Deputy of Ministry of Health Environmental and Occupational Health Center announced that

reception halls are allowed to operate in cities of blue and yellow status. The maximum number of participants allowable in a hall is 75 people in blue cities and 55 in yellow ones. However, in outdoor halls the maximum capacity may be twice these numbers. The maximum duration of events is 3 hours.

Which businesses are closed?	According to the statement by Iran's Chamber of Guilds , the closure of businesses is not relevant anymore. This is in line with the new scheme of "the smart management of COVID-19," which requires all business owners to get vaccinated and register at asnaf.moi.ir , along with observing health protocols, to get permission to operate. Public office employees should get fully vaccinated or provide a negative PCR test result every 2 weeks to be able to attend work.

Except the excluded passengers, all arriving passengers must have negative PCR test result issued at most 72 hours prior to their travel to Iran regardless of duration of stay overseas along with the official proof of vaccination. The test result must be in English or stamped and confirmed by Iranian consulates. Passengers without negative test result are not allowed to enter Iran. If the international traveler is arriving from the high-risk countries (list is annexed), at least 14 days must have been passed from the second dose of vaccination. In addition, if airport authorities diagnose passengers with COVID-19 symptoms, another PCR test will be taken at the airport.

Passengers above 12 must have a vaccination certificate showing that they are fully vaccinated at least 14 days and at most 9 months ago. After this time, they should have a booster dose.

Passengers with a medical certificate issued longer than 72 hours before travel are subject to medical screening, Coronavirus (COVID-19) PCR test and quarantine upon arrival, at their own expense.

E-visas can be obtained before departure at http://e_visa.mfa.ir/en/.

All arriving passengers would be subject to medical screening and clinical assessment and in case of showing symptoms would be tested again. The passenger will be quarantined in assigned

locations until receiving the test result and in case of positive test result, the passenger will be accommodated in assigned quarantine locations for 14 days. Passenger shall incur costs for the test and accommodation. (IKIA Information Center)

All arriving passengers are required to fill out "COVID-19 Self Declaration Form" before arrival provided by the airline operators prior or during the flights and hand over the completed forms to the Airlines' agents. Iranian citizens without full vaccination certificate, no PCR in hand will be in temporary quarantine until the PCR test is ready. All Iranians coming from VOC countries need 14 days' quarantine and 3 PCR test during the period.

Wearing masks at all passenger terminals of Iran airports is mandatory.

Passengers are strongly advised to cross check with their air operators on the latest prerequisites and required documentations regarding negative COVID-19 test result or health certificate.
