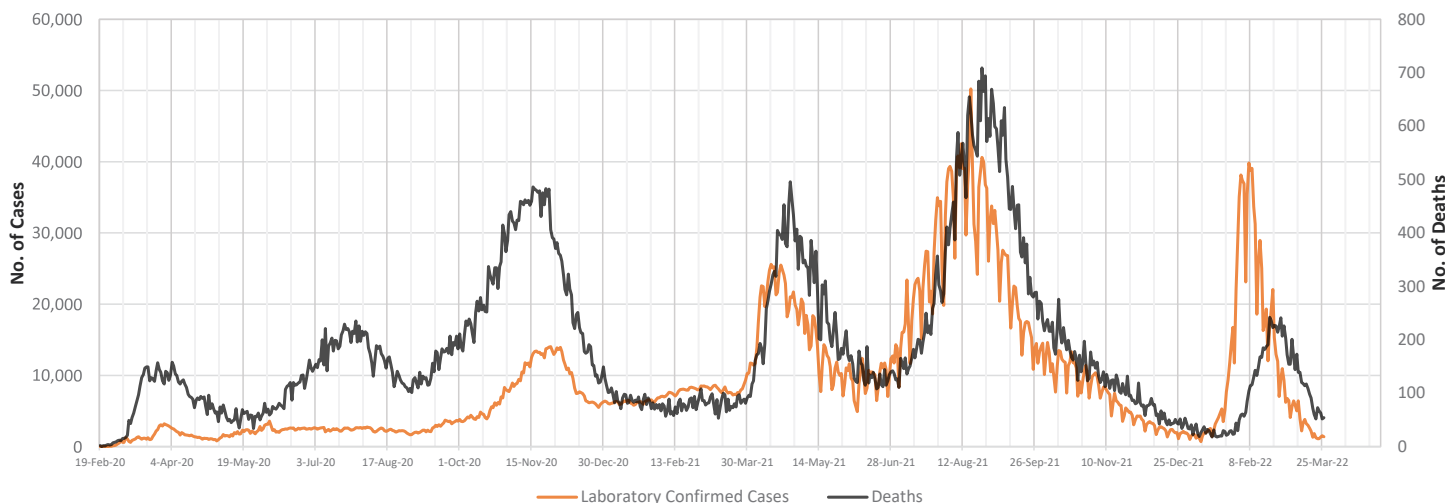

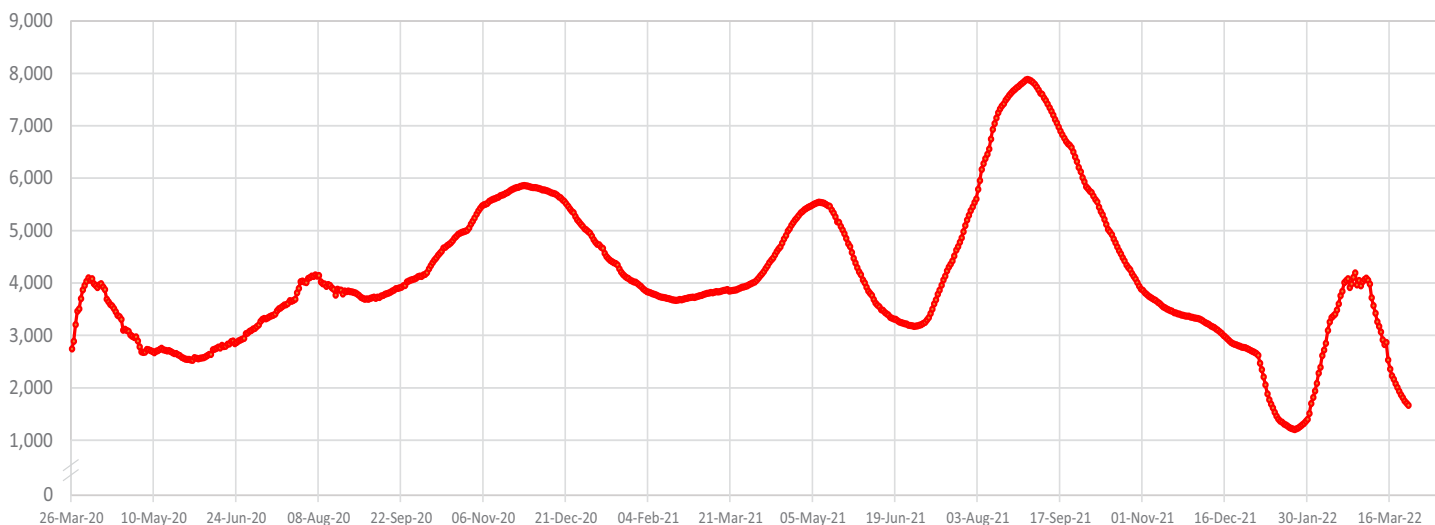

Figure 1 - Trend of COVID-19 Laboratory-Confirmed Cases and Deaths, 19 February 2020 - 26 March 2022

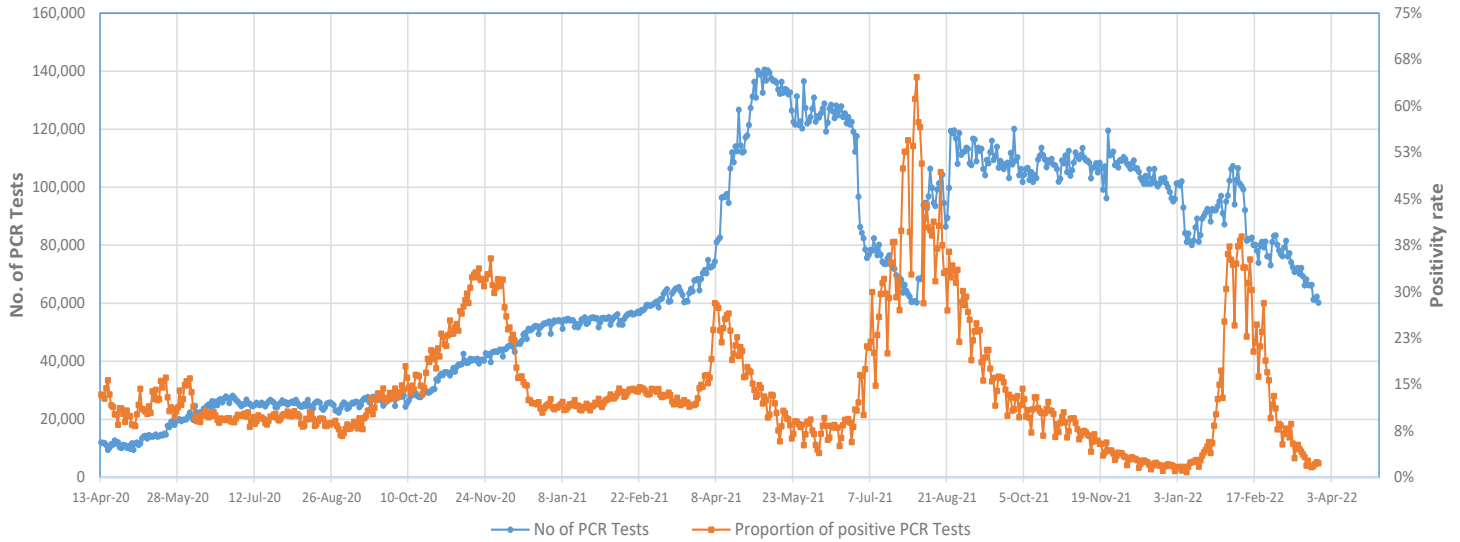

If the number of admitted COVID-19 patients in a city is <2 per 100,000 populations per day, the status of that city will be **blue**; if the number is ≥2 and <4 per 100,000 populations, the status will be **yellow**; if the number is ≥4 and <6, the status will be **orange**; and if the number increases to ≥6, the status will be **red**.


**Imposed National and Provincial Restrictions**

As a patient-tracking measure, all citizens are required to be in possession of their national ID cards as a prerequisite to gain entry to government offices, receive public services, or use public transport. Technical Deputy of Ministry of Health Environmental and Occupational Health Center announced that

reception halls are allowed to operate in cities of blue and yellow status. The maximum number of participants allowable in a hall is 75 people in blue cities and 55 in yellow ones. However, in outdoor halls the maximum capacity may be twice these numbers. The maximum duration of events is 3 hours.

This is in line with the new scheme of "the smart management of COVID-19," which requires all business owners to get vaccinated and register at <a href="http://asnaf.moi.ir">asnaf.moi.ir</a> , along with observing health protocols, to get permission to operate. Public office employees should get fully vaccinated or provide a negative PCR test result every 2 weeks to be able to attend work.

### Travel Restrictions Imposed by Iran

(Updated on 26 March 2022)

**Highlights:**

**Currently the restrictions/requirements for incoming passengers based on countries are as follows:**

**General restrictions:**

**Except the excluded passengers, all Iranian arriving passengers must have negative PCR test result issued at most 72 hours prior to their travel** to regardless of duration of stay overseas, along with the official proof of vaccination. The test result must be in English or stamped and confirmed by Iranian consulates. Iranian passengers without negative test result are subject to take PCR test upon arrival and quarantine until the result is ready.

Passengers traveling to Isfahan must have a vaccination certificate with QR code.

Nationals of Afghanistan without vaccination certificate must take the vaccination upon arrival.

Passengers above 12 must have a vaccination certificate showing that they are fully vaccinated at least 14 days and at most 9 months ago. After this time, they should have a booster dose.

E-visas can be obtained before departure at.

Passengers must have an e-visa confirmation.

**All arriving passengers would be subject to medical screening and clinical assessment** and in case of showing symptoms would be tested again. The passenger will be quarantined in assigned

locations until receiving the test result and in case of positive test result, the passenger will be accommodated in assigned quarantine locations for 14 days. Passenger shall incur costs for the test and accommodation. (IKIA Information Center)

**All arriving passengers are required to fill out “COVID-19 Self Declaration Form” before arrival** provided by the airline operators prior or during the flights and hand over the completed forms to the Airlines’ agents. Iranian citizens without full vaccination certificate, no PCR in hand will be in temporary quarantine until the PCR test is ready. Passengers are strongly advised to cross check with their air operators on the latest prerequisites and required documentations regarding negative COVID-19 test result or health certificate.
